2. The tender period shall be **14 days** from **27st April 2026** to **11th May 2026**.
3. Tenders shall be quoted in **Tanzanian Shillings (TZS)** and shall include **all applicable taxes and levies**.
4. Tenders shall remain valid for a period of **One Hundred and Twenty-Six (126) days** from the date of tender opening.

5. All tenders must be accompanied by a **Tender Security from established bank** equivalent to **one percent (1%)** of the tender sum.
6. Prices quoted shall be **fixed for the entire contract period**.
7. Pre-tender site visit at Kenya High commission, Kaunda Drive/Bongoyo Road Junction, Oysterbay, will be held on 4th May 2026 at 10:00 a.m. to 12.00 noon. (East Africa Time)

Tenders will be opened immediately thereafter in the presence of tenderers or their duly authorized representatives who choose to attend.
10. **Electronic tenders will not be permitted.**
11. **Late tenders shall be rejected.**
12. Tender evaluation and qualification criteria shall be in accordance with the requirements specified in the tender document and the **Kenya Public Procurement and Asset Disposal Act, 2015** and its attendant Regulations.
